The current zeitgeist of philanthropic commitment, "Change, not Charity" or "Help that works", focuses on the impact of projects. It shows that not only the effective implementation of projects is relevant, but also the evaluation of the work and should be considered an integral part of each project. The focus on impact enables us to address which changes have occurred and can be attributed to projects.

Foundations, social entrepreneurs, and sustainably oriented investment funds want to achieve real impact that goes beyond a purely monetary return. Impact investing and impact measurement are therefore key topics. But how can effect be measured scientifically? How can impact measurement be linked to investment decisions? How can foundations and philanthropists be scientifically and operationally supported in making their investments effective and efficient? What kind of assistance would be useful and effective at the same time?

"From Insight to Impact" has been the motto of the University of St.Gallen for years, with which scientific findings are relayed into practice. The conference is aimed at foundations, non-profit-organisations, companies, social entrepreneurs and sustainable investment funds that want to develop their activities in a more targeted and sustainable manner. Practical examples and scientific developments will be discussed in lectures and discussion forums.

The symposium will be held in cooperation with the Center for Evaluation and Development (C4ED). Under the direction of Prof. Dr. Markus Frölich (Director and Visiting Professor at the University of St.Gallen), C4ED is the leading institution in measuring the impact of development cooperation, with locations in Switzerland and Germany and projects in 60 countries in Africa, Asia and Latin America.

The symposium focuses on the evaluation of the impact of education and child development programmes, with Professor Marc Gurgand (Paris School of Economics) as guest speaker on the topics "Nobel Prize 2019 in economics for impact evaluation and rigorous evaluations of education and pre-school programmes in France". Professor Gurgand is the scientific director of J-PAL Europe (Paris) and an expert on the impact of education and child development programmes with extensive research experience, especially in France.

We look forward to an open and inspiring exchange that will further deepen the dialogue between science and practice in the philanthropy sector. We would like to welcome you to join us in this symposium.

The Center for Evaluation and Development is headed by Prof. Dr. Markus Frölich (Professor and Visiting Professor at the University of St. Gallen). Dr. Alexandra Avdeenko is its Research Director. With locations in Tägerwilen (Switzerland) and Mannheim (Germany), it has projects in more than 60 countries in Africa, Asia and Latin America, and is the leading institutions worldwide leader in measuring the impact of development cooperation.

Professor Dr. Markus Frölich received his doctorate in 2002 from the University of St. Gallen, where he has continued to work as a Research Fellow, Lecturer and Visiting Professor of Econometrics. From 2008 to 2011, he was head of the joint research programme "Employment and Development" of the World Bank and the Institute for the Future of Work (IZA). He is Professor of Econometrics at the University of Mannheim, Director of C4ED in Switzerland and Germany, affiliated Professor of J-PAL (Poverty Action Lab, MIT) and Research Professor of Innovation for Poverty Actions (IPA). His main areas of research are methods for impact evaluation and applied impact evaluations, in the fields of labour market, poverty, education, health, climate change and agriculture, in countries across Africa, America, Latin America and Asia. He has conducted impact evaluations for national and international organisations and governments, including SDC, GIZ/KFW, IFAD, ILO, UNICEF, UN Climate Fund (Green Climate Fund), UN World Food Programme (UN-WFP), World Bank, and the International Initiative for Impact Evaluation (3ie).

Dr. Alexandra Avdeenko is Research Director of the Center for Evaluation and Development (C4ED) in Germany. She heads the departments Knowledge Transfer and Management and Cooperations with Foundations and NGOs as well as multiple research projects for ACTED, UNICEF, and the World Bank in Africa and Asia, for example in Ethiopia, India, Indonesia, Pakistan, and Sudan.
